3. Obtain a **Ticket Number** and a **Start Date** from Diggers Hotline for the location of the driveway.
4. Submit this application with a detailed sketch showing existing driveways, existing physical addresses and the distances between them, road intersections and other pertinent information; or attach a print out from the Oconto County website.

5. **Notify the Physical Address Coordinator**, at the number listed below, **as to what materials were used to mark the driveway. Upon notification, a number will be assigned within (10) ten working days.**

If the above conditions are not met upon the county's onsite, the number will not be issued. Applications will then be delayed until owner provides proper documentation for issuance of a number.
