CHAPTER 22
SNOWMOBILES

22.01 STATE SNOWMOBILE LAWS ADOPTED. Except as otherwise specifically provided in this Chapter, the statutory provisions of Chapter 350, Wis. Stats., describing and defining regulations with respect to snowmobiles exclusive of any regulations for which the statutory penalty is a fine or term of imprisonment are hereby adopted by reference and made part of this Chapter as if fully set forth herein. Acts required to be performed or prohibited by such statutes or regulations are required or prohibited by this Chapter. Any future amendments, revisions, or modifications of the Statutes incorporated herein by reference are intended to be made part of this Chapter in order to secure to the extent legally practicable uniform statewide regulation of snowmobiles in the State of Wisconsin.

22.02 APPLICABILITY OF TRAFFIC REGULATIONS TO SNOWMOBILES. No person shall operate a snowmobile upon any street, road, highway, or alley in Oconto County in violation of the traffic regulation provisions of Sec. 346.04, 346.06, 346.11, 346.14(1), 346.18, 346.19, 346.20, 346.21, 346.26, 346.27, 346.33, 346.35, 346.37, 346.39, 346.40, 346.44, 346.46, 346.47, 346.48, 346.50(1) (b), 346.51, 346.52, 346.53, 346.54, 346.55, 346.87, 346.88, 346.89, 346.90, 346.91, 346.92(1) and 346.94(1), (6), (6m) and (9), Wis. Stats.

22.03 PENALTY. (a) Forfeiture; Penalty. The penalty for violation of any provision of this Chapter shall be a forfeiture as hereafter provided together with court costs and fees and the applicable penalty assessment. Forfeiture for violation of any snowmobile regulation set forth in the Wisconsin Statutes adopted by reference in Sec. 22.01 shall conform to the forfeiture penalty permitted to be imposed for violations of the comparable Wisconsin Statute including any variations or increases for subsequent offenses.

(b) Applicable Court Procedures. Except as otherwise specifically provided by the laws of this State or this Chapter, the snowmobile regulation in this code shall be enforced in the Circuit Court in accordance with the provisions of the Chapters 23, 345, and 799, Wis. Stats.

(c) Citations. The citation described in Chapter 23 and 345, Wis. Stats., shall be used for the enforcement of those violations adopted herein at Section 22.01.

(d) Deposits and Stipulation. Persons arrested or cited for violations of snowmobile offenses created by this Code shall be permitted to make deposits and stipulations of no contest or released by the arresting officer in accordance with the applicable provisions of the Wisconsin Statutes. The deposit and stipulation shall be delivered personally by the person cited or mailed to the office of the Clerk of Court, 301 Washington Street, Oconto, Wisconsin 54153.
