16.1. Partners in Justice Grant

Committee heard a recap of the Partners in Justice grant application timeline and how the VIP program is used by the courts. Discussion followed. Included in the discussion was the announcement that Partners in Justice has a new director and is not taking any more VIP applicants at this time per an email received by Will Kline dated 01/11/2023. Due to the delay in holding a committee meeting, the financials submitted with the grant application are outdated; as such, the Committee took no action but stated the applicants could reapply in the future.
