3. **Obtain a Ticket Number and a Start Date from Diggers Hotline** for the location of the driveway.
4. **Submit this application with a detailed sketch** showing existing driveways, existing physical addresses and the distances between them, road intersections and other pertinent information; **or attach a printout from the Oconto County website.**
