A. Tower Updates

C. Property Easement for Emergency Radio System Tower (Enc.)

Spice reviewed the easement with the Committee. If this easement is completed the County will be placing a tower on Krueger Quarry road that will be owned by the County as well.

- Have been working with Corporation Counsel on to recover funds paid out on October 5, 2020 incident. Two different settlement offers have been received from the responsible parties' legal advisor but offers not adequate.
